### SUPERINTENDENTS.

The Superintendents of the Adult Deaf & Dumb Societies and Missions of Australia, Mr.A.Landers (Queensland), O.R.Redman (South Australia), E.R.Reynolds (Victoria), A.L.Lonsdale (N.S.M.), met in Sydney during the week of the 4th to 9th April and discussed various matters apertaining to the work and also the forthcoming Carnival to be held in Sydney next Christmas.

In connection with the Carnival several decisions were made these being:-

The Carnival would commence on Monday the 26th December and conclude on Monday the 2nd January.

New South Males, being the host State, will make all arrangements for the Carnival including the draw for the various matches and events.

Tennis teams competing for the R.Cohen cup would consist of 4 men and 2 ladies as at the Queensland Carnival.

The Jones Cup would be decided by Point Score - a win in an event to be one Point. In the event of a tie, then "runners up" would count.

The following events would if possible be conducted:-

LADIES. Table Tennis singles, Quoits, Chess, Draughts. MENS. Table Tennis singles, Billiards, Snooker, Chess, Draughts, Quoits-providing there be an entry in any section from at least two states. Each state could enter two representatives in each event but no contestant could compete in more than two events.

A number of signs were discussed and agreement on a uniform sign for some 80 signs was reached. A number were already in compared there existed a disc use by all states but for about 20, where there existed a difference it was decided to use a sign used by a particular state or states and which was considered the most appropriate.
